Part A: Pupil premium strategy plan

Statement of intent

When making decisions about our use of Pupil Premium and Recovery Premium funding, we have considered the context of the school following a global pandemic and the subsequent challenges faced by pupils at Victoria Primary Academy.

Victoria Primary Academy is a large two-form entry primary school in Leeds 9, an area of high social disadvantage. 58% of pupils are eligible for Pupil Premium funding and we use this funding to mindfully improve educational outcomes for this large majority. Although all pupils benefit from many elements of our provision, we have a good understanding of the barriers to learning which can influence disadvantaged children, in particular, and have developed a curriculum offer that seeks to meet the needs of our pupils.

Principles

We ensure that the quality of teaching is good and that lessons are carefully designed to meet the needs of all the pupils and accelerate progress towards age related expectations.

We ensure that we have good systems for the assessment of all pupils, and that our analysis and planning for future learning is detailed and precise.

We have a sharp focus on equality of opportunity for all pupils and are fully committed to providing our children with the knowledge, skills, and experiences which they need to access the next stage of their educational journey, and beyond.

Practice

Strategies to enable all pupils to achieve well may include:

- Increasing the attendance and punctuality of all pupils
- Increasing adult: pupil ratios within Quality First Teaching, enabling small group work and a commitment to same day intervention for pupils at risk of underachievement
- Investing in the range of curriculum, before and after school resources and experiences so that all pupils have the opportunity to learn an instrument, to learn a language and participate in sporting competitions.
- Ensuring accurate assessment methodologies support teachers in the identification of gaps in knowledge
- Ensuring SEND partnerships enable the early identification of need, and that high quality advice and support is available to teaching, support staff and families.
- Contribution towards activities, educational visits and residential, ensuring children have first-hand experiences to use in their learning in the classroom.
- The funding of specialist learning software and devices
- Behaviour and nurture support during lunchtimes by providing activities to engage and promote the Victoria Promise and thus enhance learning.
- To allocate a 'Catch Up' Teacher to each Year Group providing small group work focussed on overcoming gaps in learning.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Our assessments and observations indicate that the education of many of our disadvantaged pupils have been impacted by partial school closures to a greater extent than for other pupils. These findings are supported by national studies. This has resulted in significant knowledge gaps leading to pupils falling further behind age-related expectations, low attainment in Phonics, Reading, Writing and Maths and some aspects of the foundation curriculum disproportionately impacted by COVID-19 are therefore a focus for this plan.
2	Our attendance data over the last 3 years indicates that attendance among disadvantaged pupils has been between lower than for non-disadvantaged pupils, with a higher proportion of disadvantaged pupils being recorded as 'persistently absent' compared to their peers during that period. Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress. Raising the attendance and punctuality of our disadvantaged pupils is therefore a focus for this plan.
3	Our observations and discussions with pupils and families have identified social and emotional issues for many pupils, notably due to a lack of social time and enrichment opportunities during school closure. These challenges particularly affect disadvantaged pupils, including their attainment. Teacher referrals for support have markedly increased during the pandemic, with a higher proportion of pupils needing additional support with social and emotional needs. Securing positive behaviours for learning and socially acceptable behaviours during unstructured times is therefore a focus for this plan.
4	We are acutely aware of higher levels of instability at home impacting on our families, with higher levels of support required from community services and / or social care intervention. During the pandemic, we have also noted higher levels of pupil mobility and find that relationships with school staff are in the early stages of formation. Developing our strategy for supporting families in meeting their challenges is therefore a focus for this plan.
5	Despite the face-to-face attendance of a higher number of SEND pupils during the second national lockdown, the SEND needs of pupils have been difficult to accommodate during the pandemic. The absence of face-to-face external professionals, alongside the missed opportunities for school staff to operate interventions outside of bubble arrangements, has exacerbated the gap between pupils with SEND needs and their peers, with a high proportion finding accessing Quality First Teaching a challenge. A high level of SEND needs has also been identified in the Foundation Stage, with pupils who have not accessed any provision prior to starting school presenting with a wide range of needs which have not yet had appropriate assessment/identification, nor support.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2022 to 2023 academic year.

We have analysed the performance of our school's disadvantaged pupils during the 2022/23 academic year using Key Stage 1 and 2 performance data, phonics check results and our own internal assessments.

The 2023/24 is the last year of the three-year plan based on the intended outcomes. The below evaluations are identifying impact from the year 2 plan.

Data from tests and assessment has been used to analyse the performance of disadvantaged pupils against the whole cohort and non-disadvantaged groups. The data is shown below:

To help us gauge the performance of our disadvantaged pupils we compared their results to those for disadvantaged and non-disadvantaged pupils at national and local level (though these comparisons are to be considered with caution given ongoing pandemic impacts) and to results achieved by our non-disadvantaged pupils.

The data demonstrates that in Year 1, disadvantaged pupils perform less well than their peers in phonics, reading, writing and maths. However, in Year 2, this is reversed, and it is disadvantaged pupils who are outperforming their non-disadvantaged peers. This again reverses in LKS2, where disadvantaged pupils perform less well than their peers in reading, writing and maths. By the end of KS2, disadvantaged groups are performing in line with their non-disadvantaged peers in reading and writing, with the exception being maths in Year 6, where non-disadvantaged pupils have outperformed their disadvantaged peers.

We have also drawn on school data and observations to assess wider issues impacting disadvantaged pupils' performance, including attendance, behaviour, and wellbeing.

Attendance among disadvantaged pupils (92%) was broadly in line with their peers (93%) in 2022/23. However, persistent absence among disadvantaged pupils (23%) was above non-disadvantaged groups (19%) and also above the national benchmarks. We are committed to improving attendance for all of our pupils, including disadvantaged pupils, and recognise the gap between disadvantaged and non-disadvantaged is too large, which is why raising the attendance of our disadvantaged pupils is a focus of our current plan.

Our observations and assessments demonstrated that pupil behaviour improved last year, but challenges in relation to wellbeing and mental health remain higher than before the pandemic. The impact on disadvantaged and SEND pupils has been particularly acute. During last academic year, there has been further enhancements to the outdoor provision with more equipment and a wider range of sporting opportunities; this will continue this academic year. We have also increased the number of mental health first aiders and Thrive practitioners to support our nurture provision and increase the ability to support the emotional literacy and wellbeing of our pupils.

During 2022/23, we have continued to further enhance our offer for families and the wider community. We have a community hub and through this space we have hosted parental workshops with the Leeds Learning Hub, stay and play sessions, coffee mornings, and parent drop-ins. We also run a community pantry and a uniform / clothing exchange; these are all supported by local charities and donations.

Based on all the information above, the performance of our disadvantaged pupils did not meet our expectations overall, despite the performance of our disadvantaged pupils meeting, and in some areas, exceeding expectations. At present, we are not on track to achieve all of the outcomes we set out to achieve by 2024/25, as stated in the Intended Outcomes section above. Therefore, we have reviewed our strategy plan and made changes to how we intend to use some of our budget this academic year, as set out in the Activity in This Academic Year section above.
